#### COUNCIL REGULATION (EC) NO 705/2008

This Notice is issued in respect of the financial sanctions against the illegal authorities of Anjouan in the Union of the Comoros.

Her Majesty's Treasury issues this notice to advise that following the adoption of Council Regulation (EC) No 705/2008 on 24 July 2008 by the Council of the European Union, the restrictive measures imposed by Council Regulation (EC) No 243/2008 against the illegal government of Anjouan and certain associated persons have been lifted with effect from 25 July 2008.

Council Regulation (EC) No 705/2008 was published in the Official Journal of the European Union on 25 July 2008 (O.J. L197, 25.7.2008, P.1). The Regulation is directly applicable in the UK.

For ease of reference the names of the individuals previously designated by the Council of the European Union in Annex I to Council Regulation (EC) No 243/2008 are shown in the Annex to this Notice. The individuals have been removed from the Consolidated List on the Treasury's website.
