



Financial Sanctions Notification

22 June 2009

Al-Qaida and Taliban

This notification is issued in respect of the financial measures taken against Al-Qaida and the Taliban.

Her Majesty's Treasury issues this notification to advise that on 18 June 2009 the United Nations (UN) Sanctions Committee approved the addition of one individual to the UN Consolidated List maintained under Resolution 1390 (2002). The individual therefore falls within the UK financial sanctions regime under the Al-Qaida and Taliban (United Nations Measures) Order 2006. Details of the addition are set out in the Annex to this notification.

Financial institutions and other bodies and persons are required to check whether they maintain any accounts or otherwise hold any funds or economic resources for the individual named in the Annex and, if so, they should report to the Treasury details of all funds or economic resources that they have frozen.

The Consolidated List of Financial Sanctions Targets which is maintained on the Treasury website has been updated to reflect the addition.
