Council Implementing Regulation (EU) No 1345/2011 (Investment ban - Annex V to Council Regulation (EC) No 194/2008)

This notification is issued in respect of the restrictive measures directed by the European Union against Burma/Myanmar.

1. With the publication of Council Implementing Regulation (EU) No 1345/2011 of 19 December 2011 in the Official Journal of the European Union (O.J. L338, 21.12.2011, P.19) on 21 December 2011, the Council of the European Union has amended Annex V to Council Regulation (EC) No 194/2008 ("the 2008 Regulation") with effect from 21 December 2011.
2. Annex V to the 2008 Regulation lists the entities subject to certain export, financing and investment restrictions under that Regulation.
3. The amendments made take the form of revised identifying information for one existing entry.
4. Details of the amendments are set out in the Annex to this notification.
5. The List of Investment Ban Targets, which is maintained on the Treasury website, has been updated to reflect the amendments. The Treasury's Consolidated List of asset freeze targets is not affected.
