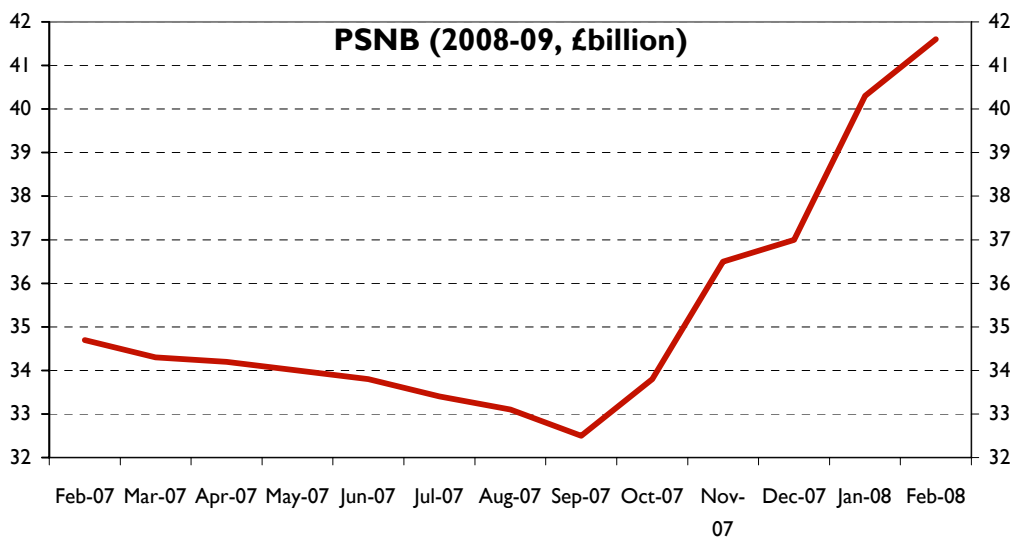
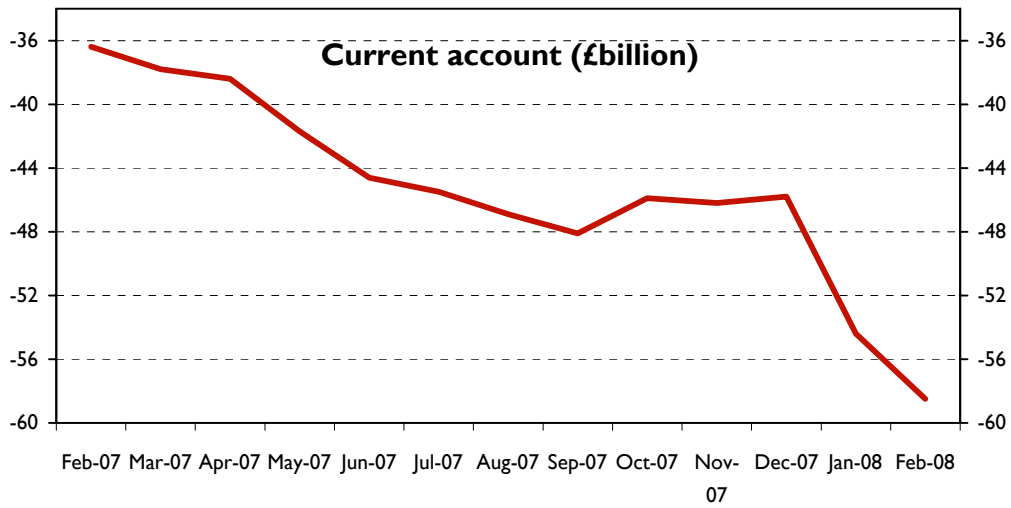
Average of independent forecasts for 2007; Current account and PSNB (2007-08)



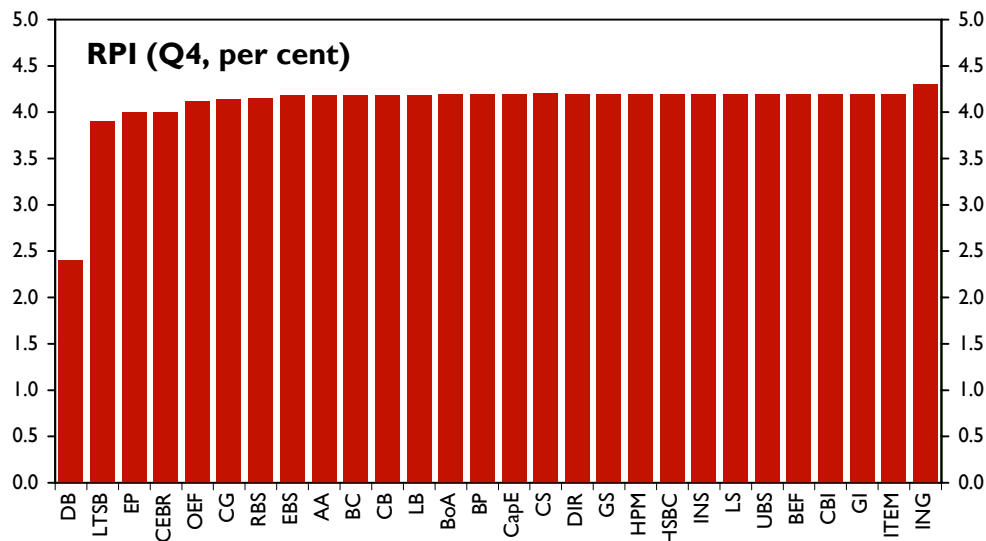
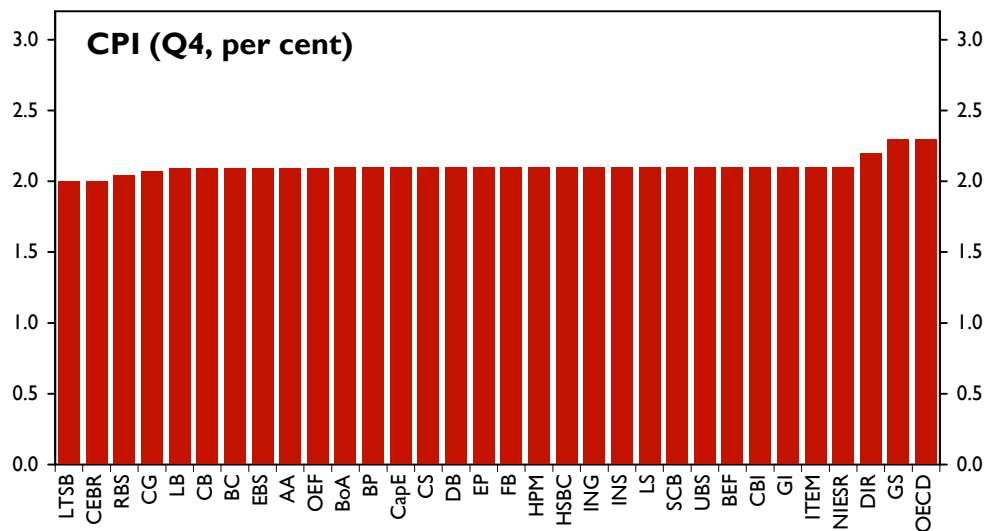
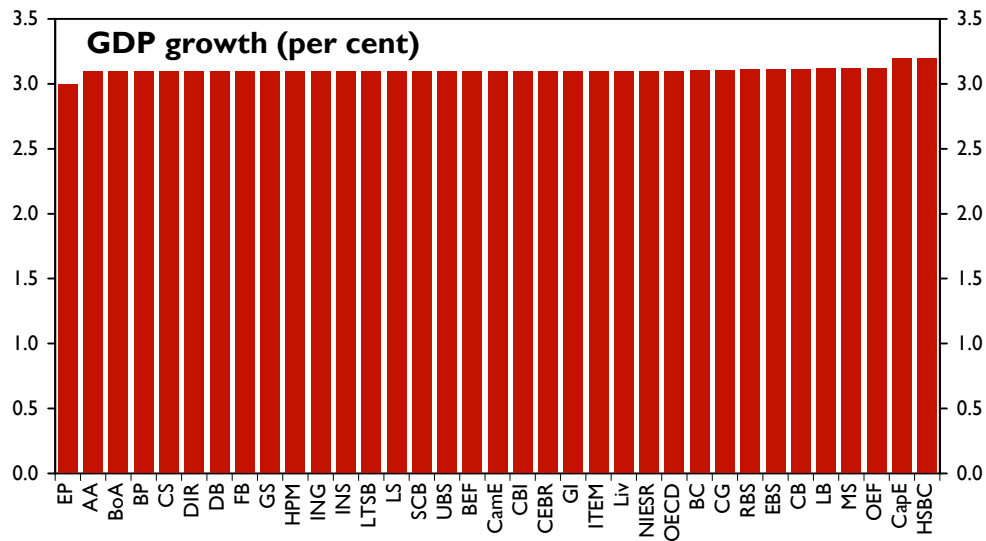
